**Route of Entry:** Eye, Skin contact, Skin absorption, Inhalation, Ingestion.

**EFFECTS OF ACUTE EXPOSURE:**

**Eye:** Causes chemical burns. May cause blindness.

**Skin:** Causes chemical burns. May be absorbed through the skin.

**Inhalation (mists):** May cause respiratory tract irritation or chemical burns.

**Ingestion:** Harmful if swallowed. May cause chemical burns to mouth, throat and stomach.

**EFFECTS OF CHRONIC EXPOSURE:**

**Skin:** Based on published data, 2-Butoxyethanol may be absorbed through the skin in toxic amounts if contact is repeated and prolonged; may cause blood damage; these effects have not been observed in humans. 2-aminoethanol may cause liver and kidney damage; these effects have not been observed in humans.

**Irritancy:** Corrosive by WHMIS criteria.

**Respiratory Tract Sensitization:** No data available.

**Carcinogenicity:** Non-hazardous by WHMIS criteria.

**Reproductive Effects:** Hazardous by WHMIS criteria (contains 1-Methyl-2-pyrrolidone).

**Teratogenicity, Mutagenicity:** No data available.

**Gloves:** Rubber gloves. Confirm with a reputable supplier first.
